

In Memory of:

Warren Rutley Pugh

August 29th, 1920—June 11th, 2009



Warren spent 54 years leading and volunteering in our neighborhood. He was a two term president of the club, and last served with his wife Gene as Club Historian before moving to Wesley Gardens in Des Moines. It is Warren and Gene, with the help of their many friends and neighbors, who put together our Direc-

tory's *First Fifty Years* (now 63 years) which we maintain and update to this day.

Warren was educated as an architect and first came to Seattle in 1941 to work as a Boeing engineer during WWII. In 1946 he joined the John W Maloney architectural firm designing hospitals, churches and schools. In 1965 he opened his own office in Auburn where he designed residential and commercial buildings. According to Kitty Milne, Warren was also instrumental in founding our City of Burien.

Warren was tireless and opinionated in support of his community and his vision for it—Traits equally feared, envied, and admired by those who knew him. He is survived by his wife of 62 years; Imogene, his two boys, his sister, his grandchildren, and a new great-grandchild. We need more folks like Warren, and we are going to miss having him around.

Special Meeting of the Membership Report

Using traffic calming to slow speeders.

July 2: Approximately 75 members of our community, Burien officials and others, met in the Shorewood Elementary School Gym to discuss speeding problems in and around our neighborhood.

The controversy began several years ago as a group of people residing along SW 130th St began an effort to slow traffic by petitioning Burien for road modifications. Over time leaders of this group proposed additional signage, speed bumps, and traffic circles be used to slow cars between Ambaum and Shorecrest Dr. Also proposed was the addition of three new full stop intersections; two on Shorewood Dr and one on 130th St at 14th Ave SW.

By the end of last year Burien had made many efforts to slow traffic on this route. They installing rumble strips on the road, posting police officers with speed guns, provided residents equipment to detect speeders, and hired an independent firm to perform a speed study.

Not satisfied with results, the 130th group continued to press for more significant changes. Their efforts culminated in a meeting between the group's leaders and Burien officials, where an agreement was reached to implement more drastic measures to slow traffic. A note regarding this agreement, and detailing the agreed changes, found it's way to us - bringing their movement to the full attention of your SOTS Board.

A meeting between leaders of the SW 130th group and three SOTS officers took place at the corner of SW 131st street and Shorewood Dr on June 15. Parties at the meeting agreed on most of the proposed changes, but failed to agree on the installation of additional stop signs. The 130th group being in favor of installing additional full stop intersections along the route, and SOTS being against.

At the July 2 Special Membership Meeting, after thorough discussion, a vote cast by attendees resulted in only one vote being recorded in favor of additional stop signs. Burien has therefore agreed no additional stop signs will be installed within the control area in question. Also agreed, and soon to be implemented by Burien, is the removal of private improvements on the road right of way and any existing obstructions to line of sight along this route, making this a safer route for all.

one mechanism for group notifications, but has the disadvantage of requiring you to be a member to gain access. We are testing this option, so we sent invitations for all our neighbors to join. So far Facebook works well, but are exploring several other options as well.

Now, if you received an unsolicited email from me personally you most likely received a club notice or a test message, and not a real estate solicitation. However, if you are inconvenienced or offended by these messages we can easily remove you from our contact list. Please call me or Prez Gary Gibson directly if you would like to be removed, or simply reply to the message received and we will promptly take care of it for you.
