2019 Annual Meeting - November 21

The SOTS Community Club Board needs your participation and your vote to elect the Board for 2020. This is your opportunity to VOTE and make a difference. Our Annual Meeting is scheduled for Thursday, November 21st from 6:30 PM until 8:30 PM at Shorewood Elementary School. We will start with our usual business portion which includes elections of new Officers and Board Members.

We will be electing 3 board members (Directors) and 3 officers: President, Vice-President and Secretary. Only one person per parcel can be on the Board. The qualifications follow.

- Directors: Have been a voting member of the club (meaning you own your property and paid SOTS CC dues) in 2019 and will maintain voting status (pay dues) in 2020. Term is 3 years. The main requirement for a Board member (director) is to show up as often as possible to Board meetings and cast the vote on issues that need voting on.
- Secretary: Same as above. Term is 1 year.
- Vice-President: Same as above. Term is 1 year.
- President: Has been a member of the board for 2019 and attended 50% of meetings (including Annual meeting and monthly Board meetings), and will maintain voting status in 2020.

Halloween candies - where to?

We are getting closer to that darkest night of the year, full of dressed and excited kiddos knocking our doors. I love that night! But not so much leftover candies. You can never estimate how much you need, since from year to year the number of guests varies so much.

Here are a few helpful ideas of where you can give those candies to save your family from sugar shock.

The Halloween Candy Buy Back program has dental offices across the country that will buy your candy for \$1 a pound (or in exchange for dental products) and send the candy and tooth brushes to troops. It usually is a scheduled buyback event, which needs to be set by participating dentist. The closest participating dentist office to Shorewood is Seattle Kids Dentistry on Elliott Ave W in Seattle. Another way is to ship candies directly to non-profit troops or veteran support organizations, or those who help sick kids and their parents. Check out the following:

Easement and beach access

In 1958 an easement was granted to the Shorewood on the Sound Community Club that at some point became commonly known as the "boat ramp". That label has caused confusion and misinterpretation of what the easement was intended to do. As stated, "said easement is for the purpose of allowing access to Block "H", Shorewood Addition No. 1, and Block H of the unrecorded plat of Shorewood Addition No. 2, known as the Shorewood Community Beach, and for the purpose of loading and unloading small the easement also clearly states that there will be no parking on 30th SW except as is necessary for access to the community beach or for loading and unloading small boats across the described easement. There is no parking on the easement itself.

In the last year there has been confusion around its location and use, and it seems some amount of disrespect of the residents adjacent to the easement during its use. The easement and use of the easement are rights of the residents of Shorewood on the Sound. But those residents must use it at all times in a way that respects the rights of the easement's neighbors.

The road on SW 30th Street behind the gate is a private road. The residents of 30th SW have reported people walking the private road and, when asked about it, were disrespectful to those residents. Users of the easement have been reported using private garbage cans to dispose of animal waste. To them it might seem OK, but it is not to the residents without their direct approval.

Shorewood on the Sound has a garbage can and garbage pickup directly at the top of the stairs going/coming up from the beach. If there is a need to dispose of anything, it should be there, and not in the containers of residents on 30th.

As a Community we are only as strong as the respect and consideration we give to all the members of our Community. Kindness and consideration are always warranted behaviors when communicating with the members of our Community. As the President of the Community Club these past 4 years and as a resident of the Community for over 20 years, I see not as many complaints as someone might expect. However, the complaints have been fairly consistent around certain issues. I have always done my best to listen and address each and every concern with respect to the complaint and the resolution of it. However, let us always remember that our opinion may not be the only way of looking at things. With that in mind it might be easier to find the common ground that brings a friendly resolution.
